Mayor's Message



What a long year it has been since last spring when our worlds got turned upside down by the pandemic. We have had a number of challenges over the past year but we are seeing improvements on all fronts. I am optimistic that this is a summer of recovery and the sooner we can all get out and enjoy our beautiful surroundings the closer to normal we can feel. Plans and conversations about activities for the community and on The Green are being discussed that include live music, food trucks and maybe even an Oktoberfest. Most folks have had at least one if not both of their vaccine shots and can now go out more confident about not getting sick.

We also have reached an agreement with Roswell for providing our E911 dispatch and ambulance services. Fulton County Sheriff Patrick Labat has committed to providing us policing services and has already proven he is holding to that commitment. Fire protection agreements/arrangements are still

being discussed and negotiated between our MPVFR and Roswell. We will hopefully have a final agreement within the next week or two.

I want to take a moment to discuss what I consider to be an important matter that affects us all. Regardless of how our fire protection services are resolved we are fortunate to have MPVFR within our city. We know there are needs for improvement in the number of fire fighters/EMTs and occupancy hours of the fire station. MPVFR will be a critical link for us if we cannot reach a contractual agreement with Roswell. We will depend solely on MPVFR as the first responders and the connection with Roswell / Woodstock as mutual aid partners when the emergency situation calls for it. For those citizens who say "dissolve the charter and be part of Roswell" that isn't going to happen overnight if at all. During the time it would take to make that a reality you have to consider who will be answering your call if you have a house fire. For those who say "file an injunction against Roswell for these services" what if the judge flat-out turns us down? It is unnecessary to criticize and demean the men & women of MPVFR on social media. MPVFR have not given up on us and we should not give up on them. We need to continue to support them as long as they are a part of our community. We can invest and build back our MPVFR to a level that gives us more confidence in our safety and pride in our community. We can have the mutual aid agreements for those times when the emergency is beyond our capabilities which fortunately have been few and far between.

We do not know what the ultimate future holds for Mountain Park but we know that one day we may not be able to continue because of the growing cost of being a city. We may finally be forced to become a part of Roswell and no longer be the unique eclectic little community in North Fulton. I think we still have a future as that City and I for one am in no hurry to let that future go away.

Stay safe and healthy.

The guidelines must be initialed by all pass holders and handed in with the Pool Tag Registration.

Code Enforcement in Mountain Park

Parking Updates!

Earlier this year the City Ordinances regarding parking were updated and clarified by our City Council to address ongoing concerns either with the scope of the existing rules or the ways in which they were being interpreted. Now Code Enforcement is required to enforce these new or revised ordinances, so heads up!

The first set of changes had to do with prohibited vehicle parking. The solution to the problem of people parking at all hours of day and night in city designated parking spaces

Section 58-125 (5) reads as follows.

...no person shall:

Park a vehicle overnight in a designated public parking area, including paved or unpaved parking areas that are in or adjacent to any park, city swimming pool, dam, city hall or city-owned building, unless the vehicle is being parked by a city officer, employee or agent in the course of city business, without prior approval from the mayor or city administrator. The mayor or city administrator may approve overnight parking of private vehicles in public parking areas upon a finding that the parking will not unduly interfere with city business, will not be a nuisance, and may assist in limiting traffic congestion or interference on the public roads of the city.

This new code section addresses overnight parking for persons using the city park for sleeping overnight after it is closed to the public, and for illicit or immoral activities on public property, among other concerns.

The second set of changes is reflected in revised code Sec. 58-126. - Restricted vehicle parking, which now reads as follows:

(a) Within the residential districts of the city, passenger vehicles and noncommercial trucks shall be parked within a garage, carport or accessory structure or on a paved driveway providing ingress and egress to a residential lot on which an occupied dwelling exists. Vehicles shall not be parked on unpaved areas of the lot, or on lots upon which there is no occupied dwelling unit....

This revised language clarified the code section to outlaw parking on unpaved surfaces on an occupied lot or *any* parking on a vacant lot. The previous language was tightened up on this, especially with respect to parking on vacant lots. Now addressed.

We still have problems with unsightly junked and abandoned vehicles being parked on paved and unpaved surfaces of property in Mountain Park. While different code sections may apply, all have the intent of restoring and maintaining the City as a beautiful and safe place to live, and in which we can all take pride.

Know Your City Code



NOISE ORDINANCE

Sec. 113-42. General prohibition.

It shall be unlawful for any person to make, continue or cause to be made or continued any loud, unnecessary or unusual noise or any noise that unreasonably or unnecessarily annoys, disturbs, injures or endangers the comfort, repose, health, peace or safety of others in the city.

Sec. 113-45. Enumeration.

The acts contained in this article, among others, shall constitute a violation of this article; but such enumeration shall not be deemed to be exclusive.

- (1) *Construction or repairing of buildings.* It shall be unlawful for any person to operate or permit the operation of any tools or equipment used in construction, drilling, or demolition work on weekdays between the hours of 7:00 p.m. and 7:00 a.m., such that the sound therefrom creates a noise disturbance across a residential real property boundary, except for emergency work of public service utilities or by special variance. No home construction shall be allowed on Saturday or Sunday except for construction between the hours of 9:00 a.m. and 7:00 p.m.
- (2) *Domestic animals.* It shall be unlawful for any person owning or keeping an animal to allow that animal to continuously (exceeding 15 minutes in duration, or greater than five minutes between the hours of 9:00 p.m. and 10:00 a.m.) or repeatedly (consisting of 15 minutes over the course of one hour) howl, bark, whine or make other loud noises plainly audible from inside any adjacent or nearby residential structure owned by any person other than the animal owner.
- (3) *Domestic power tools.* It shall be a violation of this article to operate or permit the operation of any mechanically powered saw, drill, sander, grinder, lawn or garden tool, lawnmower, or other similar device used outdoors, other than powered snow removal equipment, between the hours of 9:00 p.m. and 7:00 a.m., or on Saturday or Sunday before the hour of 9:00 a.m.
- (4) *Explosives, firearms, or similar devices.* It shall be unlawful for any person to use or fire any explosives, firearms, or similar devices which create impulsive sound so as to cause a noise disturbance across a real property boundary or on a public space or right-of-way, without first obtaining a special variance.
- (5) *Loading; unloading; opening boxes.* It shall be unlawful for any person to load, unload, open or close boxes, crates, containers, building materials, garbage cans, or similar objects between the hours of 9:00 p.m. and 7:00 a.m. on weekdays and between the hours of 9:00 p.m. and 9:00 a.m. on weekends in such a manner as to cause a noise disturbance across a residential real property boundary.
- (6) *Loudspeakers; amplifiers.* It shall be unlawful for any person to use, operate, or permit the operation of any loudspeaker, public address system, mobile sound vehicle or similar device amplifying sound therefrom on a public right-of-way or public space for any commercial purpose. Further, it shall be unlawful to use, operate, or permit for any noncommercial purposes any loudspeaker, public address system, mobile sound vehicle, or similar device between the hours of 9:00 p.m. and 7:00 a.m. on weekdays and between the hours of 9:00 p.m. and 9:00 a.m. on weekends.
- (7) *Powered model vehicles.* The operation of, or permitting the operation of, a powered model vehicle so as to create a noise disturbance across a residential real property boundary in a public space between the hours of 9:00 p.m. and 7:00 a.m. on weekdays and between the hours of 9:00 p.m. and 9:00 a.m. on weekends, shall be a violation of the provisions of this article.
- (8) *Radios phonographs, musical instruments and similar devices.* It shall be unlawful for any person to operate, play, permit the operation or playing of any radio, television, phonograph, drum, musical instrument, or similar device:
 - a. Between the hours of 9:00 p.m. and 7:00 a.m. on weekdays and between the hours of 9:00 p.m. and 9:00 a.m. on weekends in such a manner as to create a noise disturbance across a residential real property boundary, except as allowed by permit issued by the mayor and city council; or
 - b. In such a manner as to create a continuing noise disturbance at 50 feet from such device, when operated in or on a motor vehicle on a public right-of-way or public space.
- (9) *Vehicle repair in residential areas.* The repairing, rebuilding, or testing of any motor vehicle, motorcycle, motor bicycle or motorboat in such a manner as to cause a noise disturbance across a residential real property boundary in any residential district.

Pool Tag Registration Information - 2021

Adults are considered 18 years and older.

Adults 60 years and older receive a \$5 discount off their season pass

Children Ages are considered 3 to 17: 2 and under are Free

All children 11 and under must be accompanied by a Paid Adult in the pool area.

In order to qualify for a family pass, individuals must be immediate family members who live at the same residence (two adults only) and all the children must be under the age of 18 or 21 with a 2021 school ID (three children only) and related to one or both of the adults as offspring or by marriage, adoption and foster care placement or legal guardianship. No guests may use a tag. **Each tag number is specific to the name listed on the application.**

Fire department members' family and City employees get the same rates as residents.

The pool is not responsible for lost or stolen season passes. **A replacement fee of \$10.00 per tag will be charged.** Any pass reported stolen or lost, and later found to be used will be subject to Criminal prosecution. **PASSES MAY BE REVOKED FOR POOL INFRACTIONS AND MISUSE WITH NO REFUNDS.**

POOL HOURS ARE FROM 11AM TO 9PM DAILY

NO ACCESS IS ALLOWED BEFORE OR AFTER THESE HOURS.

OVERALL MAXIMUM CAPACITY OF THE POOL IS 150 PEOPLE.

ADULTS ONLY SWIMMING will be from 8 to 9pm every day. No children will be allowed in the pool area during this time.

Everyone entering the gated pool area must have a visible pool tag, punch card or purchase a daily pass wristband to use for the current day.

- **NO SWIMMING ALLOWED** unless there is an authorized lifeguard on duty.
- **NO ANIMALS ALLOWED** in the pool area at any time.
- **NO SMOKING OR VAPING ALLOWED** in the pool area at any time.
- **NO RUNNING, NO HORSEPLAY and NO PROFANITY ALLOWED.**
- **Only ONE PERSON** allowed on the diving board at a time.
- **NO DIAPERS ALLOWED and NO BLUE JEANS ALLOWED** to be worn in the pool. Only appropriate swim specific attire or swim diapers are to be worn in the pool for swimming.
- **NO GLASS, METAL OR HARD PLASTIC ITEMS, SHARP OBJECTS OR HAZARDOUS MATERIALS ALLOWED IN THE POOL AREAS.**
- **NO GRILLING** is allowed. **NO WATER FOUNTAINS** are available; please bring your own water.
- **All food and drinks must be kept 4 feet away from the pool.**
- **NO LOST AND FOUND.** All items left at the pool will be thrown away at the end of the day. Please ensure you take everything with you when you leave. The City is not responsible for items left behind.
- **High frequently touched surfaces will be cleaned throughout the day.** Chairs will only be cleaned at the end of the day. Bring your own wipes or sanitizer if you plan on using chairs.
- **NO POOL TOYS, RAFTS OR NOODLES ALLOWED. ONLY US COAST GUARD APPROVED PERSONAL FLOTATION DEVICES OR SWIMMIES ALLOWED IF NEEDED TO SWIM IN POOL.**

PASSES MAY BE REVOKED FOR NOT FOLLOWING THESE GUIDELINES WITH NO REFUNDS.

Walk-Up Vaccinations Expand to North and South Fulton

Walk-Up Vaccinations Will Also Continue at Mercedes-Benz Stadium

Fulton County's vaccination efforts continue, serving hundreds of thousands of residents since the COVID-19 pandemic began. The Fulton County Board of Health and the Atlanta-Fulton County Emergency Management Agency operate three fixed vaccination sites within Fulton County, and are working with the nonprofit agency CORE to expand the availability of mobile vaccination units to bring vaccines to neighborhoods throughout Fulton County.

Starting **Tuesday, May 4**, the vaccination sites located at the Georgia International Convention Center in College Park and 4700 North Point Parkway in Alpharetta will also begin to accept walk-ups in addition to appointments. The walk-up schedule for both sites is **10:30 a.m. to 3:00 p.m.** daily, Tuesday - Saturday. **A total of 500 walk-up vaccines will be available daily on a first-come, first-served basis.**
