On Tuesday March 23<sup>rd</sup> our City Administrator, City Attorney, Public Safety Director and myself meet virtually with the new Fulton County Sheriff Patrick Labat and Chief Deputy Antonio Johnson to discuss public safety protection for the City of Mountain Park. It was a very informative and encouraging conversation about how we can continue to provide a law enforcement presence for citizens in need of emergency assistance with an acceptable response time. Sheriff Labat has committed to having patrols in the

community as much as possible and stated he wants to add more deputies to his force. He said he would like to hire persons who live in this area of Fulton County so we may have a Sheriff's Deputy residing within in our community or in the general vicinity. There were a couple of legal issues that needed to be looked into by the attorneys and a Mutual Aid Agreement established with the City of Roswell before this is finalized. As a whole this can solve our regular policing needs in Mountain Park at no additional cost to us as Fulton County taxpayers. We appreciate their continued willingness to work out the details of this partnership to make sure that every citizen of Mountain Park has the protection they deserve.

We also continue to work hard on determining how to best enhance our MPVFR staffing needs and provide an even greater fire protection presence for residents in Mountain Park and the surrounding neighborhoods of Roswell.

I optimistic about our improving times from a year ago and look forward to seeing more people & activities on The Green and out in the community.

# Code Enforcement in Mountain Park

## TREE REMOVAL: SOME CODE COMPLIANCE GUIDELINES

Trees are an important part of The City of Mountain Park. Not only are numerous code sections dedicated to Tree Protection and Preservation, but the city has been designated a "Tree City USA" by the Arbor Day Foundation. It's safe to say the city cares about its trees.

#### Section 105-202 of the Mountain Park Code lays it out:

"The city deems it necessary and desirable in the interest of public health, safety and welfare to enact an ordinance for the conservation, planting and replacement of trees and to prevent the indiscriminate removal of trees in the city without denying the reasonable use and enjoyment of real property. The importance of trees is recognized for their shade, cooling, noise and wind reduction, soil erosion prevention, oxygen production, dust filtration, carbon dioxide absorption, aesthetic and economic enhancement of all real property, and their contribution to the general wellbeing and quality of life of the citizens of the city. Consistent with the expressed purpose of this article, all persons shall make reasonable efforts to

preserve and retain existing, self-supporting trees. It is also the intent of this article that all applicable lots within the city maintain or obtain a minimum tree density."

This time of year is a busy one for tree cutting. This year there has been even more activity than normal because of the heavy weather we have been experiencing.

A permit is usually required to cut any tree which has its roots in the ground with more than a 4" diameter.

A permit is NOT required to cut up a tree which has been uprooted and has fallen down. Nor is permit required to saw up branches that have snapped off a tree as the result of an act of nature: a storm, for example.

I hear from citizens that say, the tree was "diseased" so they "had to" cut it down. Not so. The tree ordinance does not provide an exception to the permit requirement for diseased trees.

Tree permits are easy to apply for in advance of when the tree is to be removed. Technically the permit is called an "approval letter" in the Mountain Park code. The forms can be submitted, and in many cases are applied for by the tree cutting company. It's always helpful to provide pictures in support of your application. The city arborist will then assess whether a permit should be issued.

With a permit in hand, the tree can then be lawfully removed.

## NO BURNING ALLOWED IN THE

Sec. 30-35. Outdoor burning ban.

(a) The fire chief, upon the advice and consent of council, may issue an outdoor burning ban.

- (b) After an outdoor burning ban has been enacted, said ban shall continue until such time as a majority affirmative vote of the mayor and city council ends the ban.
- (c) The outdoor burning ban shall apply to all areas within the geographic limits of the city, whether located in Cherokee or Fulton counties.
- (d) Notwithstanding the provisions contained herein, any county issued or state issued outdoor burning ban affecting property within the geographic limits of the City of Mountain Park shall supersede the city imposed ban.
- (e) Nothing in this section shall be construed to prohibit an outdoor cooking fire,



provided that the cooking fire is contained in a properly constructed fire pit, grill or fireplace and that the cooking fire is attended by a competent adult in possession of a readily accessible and adequate means of extinguishment. For purposes of this section a functioning garden hose of such length to encircle the cooking fire and located within 50 feet of the cooking fire shall be considered an adequate means of extinguishment.

#### YARD SALE GUIDELINES IN THE CITY

#### Sec. 117-27. Outside sales and yard sales.

- (a) Outside sales are not permitted on any private lot, except as provided in this section. Yard sales (which shall include garage sales and estate sales) shall be permitted at any home within the city not more than three times per calendar year. Each such sale shall be for no more than three consecutive days, and shall be limited to Fridays, Saturdays, Sundays and to Mondays that fall on a legal holiday. All remaining property for sale must be removed from the exterior of the lot by 5:00 p.m. on the next following business day. Consignment sales are not permitted, nor is the marketing of goods owned by individuals other than the residents of the lot on which the sale is being conducted.
- (b) The persons conducting the yard sale shall apply for and obtain a permit from the city clerk prior to the sale being conducted, and shall prominently display such permit at the property where the sale is being conducted during

all sale hours. The issuance of the permit shall entitle the permit holder to post not more than five  $18" \times 24"$  directional signs on the right-of-ways of the city, provided that such signs shall not obstruct traffic flow or traffic visibility. The permit holder shall remove such signs by 5:00 p.m. on the next following business day after the expiration of the sale permit. The fee for such permit shall be set from time to time by the city council.

[(c)] The fee for the issuance of yard sale permits shall be \$10.00. Such permit fee shall include the temporary parking permit fee provided for by section
