# MOUNTAIN PARK GARDEN NEEDS LEAVES

Do you need somewhere to get rid of all those leaves in your yard? Once again, this year, the Mountain Park Community Garden will accept your yard leaves. The Garden is at the corner of Spruce St and Mountain Park Rd heading towards Cherokee County. You can lean the bags against our Gate to Nowhere (you'll see). If you want to empty your bags and reuse them, you can drop the leaves into the enclosure. Leaves and pine straw only please (no branches, ivy, etc.). As a reminder we cannot take your grass cuttings unless you can assure us that you use no chemicals on your grass. This will continue through the winter.

# Code Enforcement in Mountain Park

Greetings city of Mountain Park. I, Michael Peck, am your new Code Compliance Officer. I would like to take this time to say how honored I am to serve the city and look forward to meeting each of you. During my patrols, I have noticed that there are some new constructions and renovations in the city. I would like to take this time to remind those that have not applied for building permits to visit City Hall for the necessary permit(s).

Per the Mountain Park Code of Ordinance, Subpart B – Development Regulations, Chapter 101, Article, Section 101-7: (a)(1):

*When required.* Any owner, authorized agent, or contractor who desires to construct, enlarge, alter, repair, move, demolish, or change the occupancy of a building or structure, or to erect, install, enlarge, alter, repair, remove, convert, or replace any electrical, gas, mechanical, or plumbing system, the installation of which is regulated by the construction codes, or to cause any such work to be done, shall first make application to the building official and obtain the required *permit* for the work. A *permit* shall not be issued to an owner, who is neither a licensed contractor nor the occupant of a residential structure being altered.

Please be mindful of this part of the Mountain Park Code of Ordinance. If you have any questions, please refer to the codebook on the Mountain Park website or reach out to City Hall. We will be more than happy to assist you.

# **Know Your City Code**

## Responsibilities As a Homeowner



Sec. 58-3. - Sight obstructions at intersections; notice.

(a)No person owning, occupying or in manner controlling property in this city shall permit any tree, bush or shrub on the property to project over any street or sidewalk of this city so as to obstruct or interfere with the view and use of persons walking or riding in a vehicle on the street or sidewalk or of other persons or vehicles approaching from crossing or intersecting streets.(b)It shall be unlawful for any person, whether the owner, tenant, agent or person controlling property in the city to fail to remove any tree, bush or other obstruction from the streets or sidewalks of this city after ten days' notice by the city to do so.

### Article IV. Vegetation

Sec. 113-152. - Height permitted.

It shall be unlawful for the owner, lessee, tenant, or other person having the possession and control of real property, or responsible for its management, maintenance, or upkeep, to permit the growth and accumulation of weeds, grass, or other vegetation to a height in excess of 12 inches above the ground.

Sec. 113-153. - Notice to abate.

For a violation of this article, the owner of the property shall be given notice to remove excess growth within seven days from the receipt of the notice. Such notice may be served personally, registered, or certified mail or by attaching a copy of the notice to the principal entrance of the dwelling and shall contain a description of the location of the property upon which such condition exists.

### Animal Ordinance:

- Generally running at large dogs, domestic animals, etc., dangerous, or potentially dangerous dogs is prohibited with the exception of cats.
- Dogs unlawful for owner, custodian or harborer of any dog to allow such dog to leave the premises or the owner or other such person having custody unless dog is under security of leash being no more than 6 feet in length and under the control of a competent person. Dogs must be confined to the premises of the owner or other person having custody and must be restrained by means of a fence or wall or other enclosure.
- Restraint of domestic animals it shall be unlawful for owner, custodian or harborer of any domestic animal to allow or permit such animal to leave the premises of the owner or other person having custody unless securely under leash, carry case or restrained by some other means and under the control of a competent person.



## November 5th.....Dumpster Day 7am-10am

- 1. Must provide proof of residence in the City of Mountain Park.
- 2. ONE TRUCKLOAD OR TRAILER LOAD PER RESIDENCE.
- 3. All yard debris must be cut into 3 feet sections or less.

Please note that this is a service provided by Waste Pro as a courtesy and the City of Mountain Park does not have any control over what time they arrive/depart or the rate which the dumpster fills and the amount it can hold. Please plan accordingly. Thank you!

Please ensure you put your cans out the night before after 6pm or by 7am on Wednesday and leave them at the curb until they are picked up. Please remove your cans from the curb by 8am on Thursday. No garbage will be taken that is left outside of the trash containers. No yard debris is allowed.
