Code Enforcement in Mountain Park



Greetings Mountain Park, I'd just like to take this time to remind all that have new (in progress or upcoming) constructions projects to get the necessary permits. For all of you that have had construction done (new decks, driveways, additions, etc.) and have not obtained the permit for it, enforcement for failing to obtain the necessary permit can still be done. If you would like to prevent that, then it is imperative that you contact City Hall to start the process. Otherwise, a citation(s) will be issued.

As a reminder, the code that will be enforced on all construction without permits is below:

Per the Mountain Park Code of Ordinance, Subpart B – Development Regulations, Chapter 101, Article, Section 101-7: (a)(1):

When required. Any owner, authorized agent, or contractor who desires to construct, enlarge, alter, repair, move, demolish, or change the occupancy of a building or structure, or to erect, install, enlarge, alter, repair, remove, convert, or replace any electrical, gas, mechanical, or plumbing system, the installation of which is regulated by the construction codes, or to cause any such work to be done, shall first make application to the building official and obtain the required permit for the work. A permit shall not be issued to an owner, who is neither a licensed contractor nor the occupant of a residential structure being altered.

If you have any questions, please refer to the Codebook on the Mountain Park website or reach out to City Hall. We will be more than happy to assist you.

Know Your City Code

BUILDING PERMITS

Sec. 117-14. - Building permit required.

It shall be unlawful to commence the excavation for the construction of any building or other structure, including accessory structures, or



to store building materials, or erect temporary field offices or structures, or to commence the moving, alteration, or repair of any structure, including accessory structure, until the city has issued for such work a building permit. Application for a building permit may be made through the city clerk. The process for making application, the required supporting documentation and the approval process is defined by the attachment titled, Process for Obtaining a Building/Development Permit in the City of Mountain Park.

Editor's note— The attachment cited in section 117-14 and throughout the sections following section 117-14, is not set out in this codification, but is on file in the office of the city clerk.

Accessory structure means all other impervious improvements, which include, but are not limited to, driveways, parking areas, decks, porches, pools and gazebos.

Sec. 117-15. - Approval of plans and issuance of building permit.

- (a) The city shall not approve any plans or issue a building permit for any excavation of construction until such plans have been reviewed in detail and found to be in complete conformity with the process and requirements as defined in the Process for Obtaining a Building/Development Permit in the City of Mountain Park. The application for new construction and all development permits shall include at least the following:
 - (1) Diagrams of the actual shape, proportions and dimension of the lot to be built upon at a scale of one inch equals 20 feet;
 - a. This boundary survey will also include distances to properly lines, all building setback lines, parking and driveway locations;
 - b. Existing and proposed contours at a two-foot interval;
 - c. Graphic scale and north arrow;
 - (2) Diagrams of the actual shape, proportions, location and dimension of all existing and proposed structures to be built at a scale of one inch equals 20 feet;
 - (3) Vicinity map showing site relative to nearest intersection;
 - (4) Plans must be signed and sealed by a plan preparer registered in the state of Georgia (i.e., land surveyor, engineer, landscape architect or other registered qualified plan preparer);
 - (5) Name, address and phone number of developer and owner;
 - (6) Size of project site;
 - (7) Statement from city and county tax officials that ad valorem and property taxes owed and due are paid;
 - (8) A current sewer or septic permit issued for the application property paid in full;
 - (9) A narrative defining the existing and intended use of all such buildings or other structures; and
 - (10) Diagrams of the location of erosion and sediment control practices, using uniform coding symbols from the Manual for Erosion Control in Georgia, chapter 6, with legend;
 - a. Including name and phone number of 24-hour local contact who is responsible for erosion and sediment control;
 - b. Certification by the plan preparer and owner that the site is not within 200 feet of state waters. If the site is within 200 feet of state waters as determined by the plan preparer or as determined by the city, the information in the Process for Obtaining a Building/Development Permit in the City of Mountain Park, plan review checklist B, will also be required.
- (b) The building codes applicable to all construction within the city shall be those of the county, as amended from time to time.

- 1. Must provide proof of residence in the City of Mountain Park.
- 2. ONE TRUCKLOAD OR TRAILER LOAD PER RESIDENCE.
- 3. All yard debris must be cut into 3 feet sections or less.

Please note that this is a service provided by Waste Pro as a courtesy and the City of Mountain Park does not have any control over what time they arrive/depart or the rate which the dumpster fills and the amount it can hold. Please plan accordingly. Thank you!

Please remove your can(s) from the curb by 8am on Thursday. No bin(s) that are not from WastePro WILL NOT be picked up and any trash outside of the trash bin WILL NOT be picked up. 
Volunteer

What is a Household Hazardous Waste?

Household hazardous products are products used in and around the home that contain chemicals that are hazardous to human and animal health or the environment. By definition, household hazardous products are consumer products that are toxic, corrosive, reactive, flammable, or explosive. Labels on a hazardous household product will contain the words caution, warning, or danger. There are a number of adverse human health effects from exposure to these products. After a consumer has used these products, the remainder can easily become a household hazardous waste if not disposed of properly.

What can YOU do?

How you dispose of everyday household products can impact water quality as well as your health. Use these tips to help prevent household hazardous products from becoming household hazardous waste. Be the solution to water pollution! In general:

- Buy only what you need. You'll prevent having to dispose of remaining waste.
- Never pour materials or products down the storm drain, drainage ditch, surface waters, toilets or sink drains.
- If you have leftover hazardous household products, recycle and dispose of products properly. The Center for Hard to Recycle Materials, livethrive. org/charm, accepts many hazardous materials. You can also visit earth911.com to find local recycling centers near you or contact your local government for information on proper disposal and collection events.
- Purchase non-toxic or the least toxic material and products for the job. Find free natural cleaner recipes online.
- Always follow the directions and guidelines listed on the product.
- Do not over fertilize you lawn. Consider composting kitchen scraps to use as fertilzer.

Home Improvement Projects

- Your local Lowe's, Home Depot and Batteries Plus Bulbs locations will recycle most household batteries and light bulbs. Never place these items in the garbage.
- Upcycle house paint with Global Paint for Charity, globalpaints.org. If you can't upcycle, paints can be disposed of by mixing it with sawdust or cat litter, letting the paint dry then throw it in the trash.
- Store products in their original packaging in covered areas such as a shed or garage.

Pharmaceuticals

- Drop them off at a collection site. Visit cleanwatercampaign.org/meds for more information on drop off locations.
- If you can't drop them at a collection site, mix medicine with dirt, kitty litter, or used coffee grounds and place container in the trash. Never dispose of meds by toilet or sink.

Car Maintenance

- Inspect and maintain your car regularly to prevent leaks of oil, coolant and other vehicle fluids.
- Never work on a vehicle in the street or near a stormwater drain or drainage ditch.
- Perform maintenance work on a flat concrete surface where spills can be easily cleaned up.
- Place a tarp, ground cloth, sheet of plywood, cardboard or newspaper under a vehicle to capture any leaks or spills.
- Always use a funnel when pouring liquids to avoid spills.
- Use a drip pan under a vehicle when changing fluids, unscrewing filters and removing other parts that might leak.
- Immediately clean up vehicle fluid spills with rags or other absorbent materials such as kitty litter, sawdust or oil absorbent.
- Recycle used tires, motor oil and batteries at CHaRM, livethrive.org/charm.
