## Business License Renewals

Do you have a home business that operates in Mountain Park? It's time to renew and complete a new application for your business license this year. All business license applications are due to City Hall by March 1st. The application can be found in the City Hall office or online at <a href="https://www.mountainparkgov.com">www.mountainparkgov.com</a>.

Here are the fees to be paid:

**Administrative Fee** = \$150.00

**Regulatory Fee 1-10 employees** = \$20, plus \$20 for each employee above 1 **Occupation Tax 1-10 employees** = \$50, plus \$50 for each employee above 1 So, the fee is \$220.00 for a one-person business.

If you have over 10 employees please contact City Hall for the fees.

#### Meet First Responder Kevin Sheehan

Firefighting a Family Tradition



Firefighting runs in Kevin's family. His father and grandfather were both firefighters. Many of Kevin's friends were firefighters as well. Kevin pursued his dream and graduated from the Firefighter Academy in 2007. Kevin worked for Baldwin County Fire Department for many years. When his career path took another direction, he left the fire service but remained "passionate about firefighting and helping others".

Eventually, Kevin moved to Brookfield. When he discovered that there was a volunteer fire department right next door, he contacted Chief Miceli and Lt. Peck about joining.

Kevin joined the Mountain Park Volunteer Fire & Rescue Department (MPVFR) in July of 2023. He then had to complete a re-certification process that included written, physical skills, and a live burn test. Live burn requires firefighters to go into a burning building and demonstrate their skills. Kevin passed with flying colors and was recertified as a Firefighter I.

Living in Brookfield, Kevin is literally minutes from Mountain Park. Even when he is not physically staffing at the MPVFR station, he works from home and is basically on call 24/7.

Kevin loves Mountain Park. He says, "Mountain Park is beautiful, and I love this close-knit community. Mountain Park is a special place and I appreciate those that want to keep Mountain Park, Mountain Park."

Kevin stated, "I will do whatever I can to facilitate this department. What we have is a special resource that is not available to most small cities. It is something that you don't want to lose."

Kevin encourages citizens in Mountain Park and surrounding neighborhoods to become volunteers. In addition to Firefighting and Emergency Medical Personnel, there are many ways to be involved.

## Know Your City Code

#### **CHAPTER 6 - ANIMALS**

ARTICLE I. - IN GENERAL



#### Sec. 6-1. - Fulton County provisions adopted.

The Fulton County animal control ordinance, as now or hereafter amended, is hereby adopted as a general ordinance of the city to the extent that the animal control ordinance is not inconsistent with the provisions of this chapter. A copy of the current Fulton County animal control ordinance and any additions, deletions or local amendments thereto shall be maintained in the office of the city clerk and be available for inspection by the public.

#### Sec. 6-2. - Enforcement of Fulton County animal control ordinance.

The city code compliance officer as well as the county animal control officer and county board of health are hereby given the power to enforce the Fulton County animal control ordinance in the city.

#### Sec. 6-3. - Summons.

A city officer, at his direction, may elect not to impound a dog or other animal found in violation of any section of this chapter, but to issue or cause to be issued a summons directed to the owner or possessor of the dog to appear before the municipal court on a certain day to stand trial for the violation of this chapter. (Code 1982, § 9-3-27)

### FULTON COUNTY ORDINANCES CHAPTER 34 - HEALTH AND SANITATION

#### ARTICLE VI - RABIES AND ANIMAL CONTROL

**DIVISION 1. - GENERALLY** 

#### Sec. 34-205. - Running at large.

(a) Generally. Within the unincorporated area of Fulton County or within any municipality in Fulton County which has or may enter into an agreement with Fulton County for animal control services, the running at large of dogs, domestic animals, livestock, owned wildlife, exotic animals, public nuisance animal, dangerous, or vicious dogs, or dogs trained or in training as guard dogs is prohibited, with the exception of cats. Owners of wildlife or exotic animals must have the necessary state and/or federal permits on their person when transporting their animals.

(b) (1) Dogs. It shall be unlawful for the owner, custodian or harborer of any dog to allow or permit such dog to leave the premises of the owner or other person having custody of the dog unless such dog is securely under leash; said leash being not more than six-feet long, and under the control of a competent person. Dogs must be confined to the premises of the owner or other person having custody of the dog and shall be restrained by means of a fence or wall or other enclosure, or restrained individually by a leash under the control of a competent person. Excluded are those dogs participating in or training for obedience trials, field trials, dog shows, tracking work, or law enforcement. Also, the requirements of this subsection shall not apply in any area zoned for agriculture where the owner or person having custody of the dog is at the time in question using the dog for hunting purposes and has on his/her person a valid hunting license and proof of vaccination.
